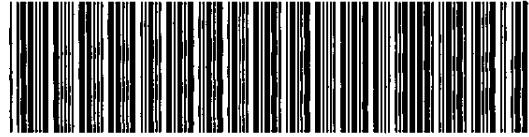

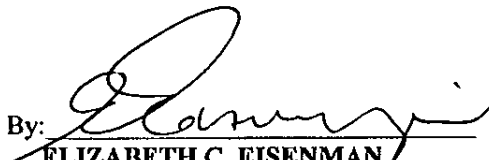
The following Articles of Merger are submitted in accordance with the Florida Business Corporation Act, pursuant to Section 607.101, F. S.:

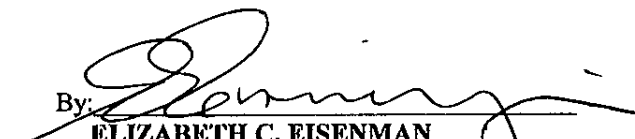

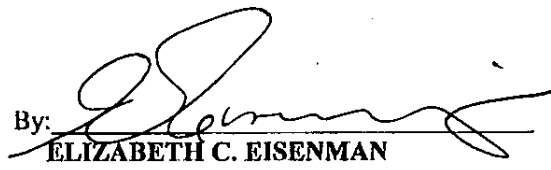
