ARTICLES OF INCORPORATION

SIGHTS AND SOUNDS, INC.

Article I - Name

The name of this corporation is SIGHTS AND SOUNDS, INC.

Article II - Duration

This corporation shall have perpetual duration.

Article III - Nature of Business

The general nature of business of the corporation shall be as follows:

- The corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.
- 2. To transact the business of investing on behalf of itself or others, any part of its capital and such additional funds as it may obtain, or any interest therein, either as tenant in common or otherwise, and selling or otherwise disposing of same, or any part thereof, or interest therein.

To acquire and take over as a going concern, and thereafter to carry on the business of any person, firm or corporation engaged in any business which this corporation is authorized to carry on, and in connection therewith to acquire the good will and all or any of the assets, and to assume or otherwise provide for all or any of the liabilities of any such business.
