## ARTICLES OF CORRECTION TO THE ARTICLES OF MERGER OF CRJ & ASSOCIATES, INCORPORATED

The undersigned officers of CRI & Associates, Incorporated, a Florida corporation (the "Corporation"), pursuant to Section 607.0124 of the Florida Business Corporation Act, hereby adopt the following Articles of Correction to the Articles of Merger:

- 1. The document to be corrected is the Articles of Merger of CRI & Associates, Incorporated, a Delaware corporation ("Target") with and into CRI & Associates, Incorporated, a Florida corporation as filed on April 5, 2002.
