ARTICLE I

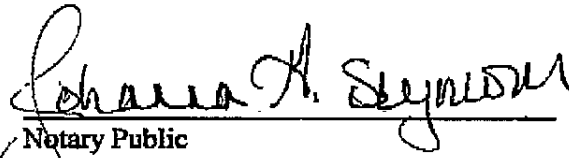
