**ARTICLE VI. INCORPORATOR**

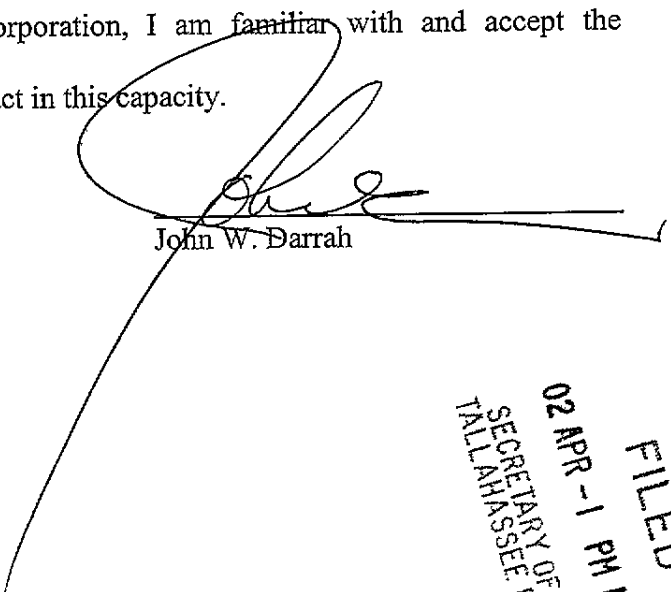
