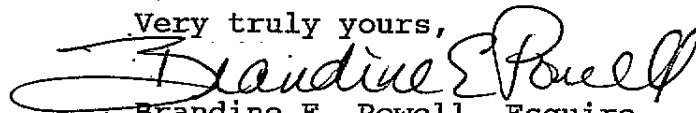

ARTICLES OF INCORPORATION

FOR

- ARTICLE I: The name of this corporation is **Your Administrative Solutions, Inc.**
- ARTICLE II: The existence of the corporation shall begin on April 1, 2002.
