ARTICLES OF INCORPORATION

OF

WCAT, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of the corporation is WCAT, INC. whose business address is 101 South Franklin Street, Suite 101, Tampa, Florida 33602 and whose billing address is 101 South Franklin Street, Suite 101, Tampa, Florida 33602.

ARTICLE II - DURATION


