ARTICLES OF INCORPORATION

of

DEBORAH G. CARVER, INC.

The undersigned Incorporator, a natural person, competent to contract, hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of creating a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation is: Deborah G. Carver, Inc.

ARTICLE II

NATURE OF BUSINESS

The Corporation is authorized to engage in the business of Court Reporting

and all other lawful business and any other transactions permitted under the laws of the United States and the State of Florida.

The Corporation shall have as many branches as may be deemed necessary.

ARTICLE III

CAPITAL STOCK

The Corporation shall be authorized to issue shares of common stock.

TERM OF EXISTENCE
