ARTICLES OF INCORPORATION

OF

FIRST. The name of the corporation is Eco Productions Inc.

SECOND. The street address of the initial principal office of the corporation is 132 Southwalk Place, St. Augustine, FL 32086.

THIRD. The total number of shares of all classes of stock which the corporation shall have authority to issue is 1,650 of which 1,500 shares of par value \$0.001 per share shall be designated as Common Stock and 150 shares of par value \$0.001 shall be designated as Preferred Stock. 
