# ARTICLES OF INCORPORATION OF BEAR FRANCHISING CORP.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

#### I. <u>Name</u>

The name of the Corporation is Bear Franchising Corp.

### II. Term of Existence

The date when corporate existence will commence is April 8, 2002 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

#### III. Principal Office

The principal office and mailing address of the Corporation is 3100 South Dixie Highway, Coconut Grove, Florida 33133.

## IV. Capital Stock

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.

# V. Initial Registered Office and Agent

#### X. B<u>ylaws</u>

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.

#### XI. Indemnification

The Corporation will indemnify any director or officer or any former director or officer, to the fullest extent permitted by law.
