
ARTICLE THIRTEEN



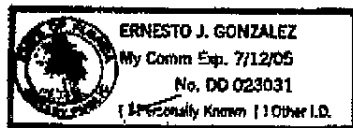
