ARTICLE I - CORPORATE NAME:

The name of the corporation is COLUMBIA TRANSPORT, INC.

ARTICLE II - NATURE OF BUSINESS AND POWERS:

The general nature of the business to be transacted by this corporation is to engage in any and all business for profit permitted under the Chapter 607 and the general laws of the State of Florida including but not limited to the general business of acquiring, owning, leasing and conveying construction vehicles and equipment. The business will be located at 11085 86th Rd. North, West Palm Beach, FL 33412

ARTICLE III - CAPITAL STOCK:

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 7,500 shares of common stock having a par value of \$1.00 per share.

ARTICLE IX - AMENDMENT:

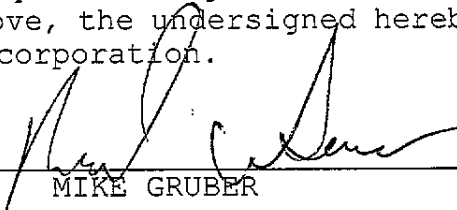

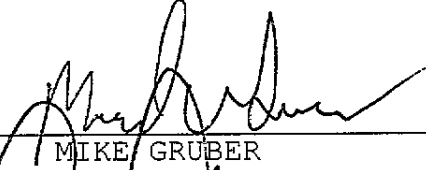
