being of legal age do hereby authorize the formation of a corporation under the laws of the State  
of Florida.

**ARTICLE I.**

The name of this corporation shall be COOL ENDEAVORS, INC.

**ARTICLE II.**

This corporation shall exist perpetually unless sooner dissolved according to law.
