The undersigned does hereby execute, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be Sirius Marine Services Corp. The principal place of business of this corporation shall be 1447 NW 27 St., Miami, FL 33142.

ARTICLE II. EFFECTIVE DATE

This corporation shall commence its perpetual existence on April 1, 2002.

This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK
