ARTICLES OF INCORPORATION OF Miami 2night, Inc.

The undersigned acknowledges and files in the office of the State of Florida, for the purpose of forming a corporation for profit, in accordance with the laws of the State of Florida, these articles of incorporation as by law provided.

ARTICLE I

NAME The name of the corporation shall be: Miami 2night, Inc. ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS:

ARTICLE III

PURPOSE

The general nature of the business to be transacted by this corporation shall be: To transact any and all lawful business for which corporations may be incorporated under the Laws of the State of Florida.

GENERAL PROVISIONS

- The private property of any shareholder shall not be subject to the payments of any (a) corporate debts to any extent whatsoever;
- A director of the corporation may transact business, borrow, lend, finance or otherwise deal or contract with the Corporation to the full extent and subject only to the limitations and provisions of the laws of the State of Florida and the law of the United States;
- The Corporation shall indemnify each director and officer of the Corporation against all or any of all expenses reasonably incurred by him in connection with or arising out of any action, suit, or proceeding, in which he may be involved, by reason of his being or having an officer or director of the corporation (whether or not he continues to be an officer or director at the time of incurring such expenses), to the full extent permitted by and subject only to the limitations and provisions of the laws of the State of Florida and laws of the United States. This provision shall be in addition to any other rights to which those indemnified may be entitled under any By-Laws, agreements, vote of shareholders or disinterested directors or otherwise, both as to action in his official capacity and is to continue as to any person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors, and administrators of such a person.
