ARTICLES OF INCORPORATION OF QUALITAS Corporation

The undersigned incorporator to these Articles of Incorporation, by these Articles formed corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is **QUALITAS Corporation**

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in any activities or business permitted under the laws of the United States and of the State of Florida.
