ARTICLES OF INCORPORATION
OF
CATS TRUCKING, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

Name and Address

The name of the corporation is CATS TRUCKING, INC. The principal office is 8400 W. Scott Court, Homosassa, FL 34448, and the mailing address for the corporation is 8400 W. Scott Court, Homosassa, Florida 34448.

ARTICLE II.

Duration

The duration of the corporation is perpetual.

ARTICLE III.

Purpose

The general purposes for which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purpose of the corporation or necessary or desirable in order to accomplish them.

ARTICLE IV.

Shares

The aggregate number of shares which the corporation is authorized to issue is 500 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

ARTICLE V.

Initial Registered Office and Agent

The street address of the initial registered office of the corporation is 8400 W. Scott Ct., Homosassa, 34448 and the name of its initial registered agent at that address is Charles Turman.

ARTICLE VI.

Initial Board of Directors

The number of directors constituting the initial board of directors is two. The number of directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than two. The name and address of each initial director of the corporation is as follows:
