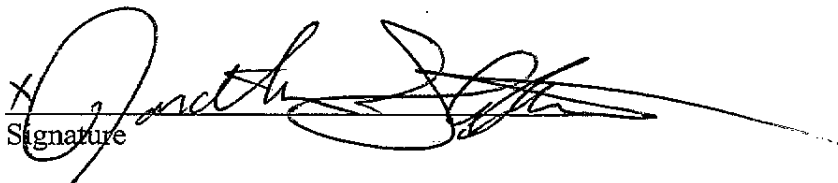
## ARTICLE VIII

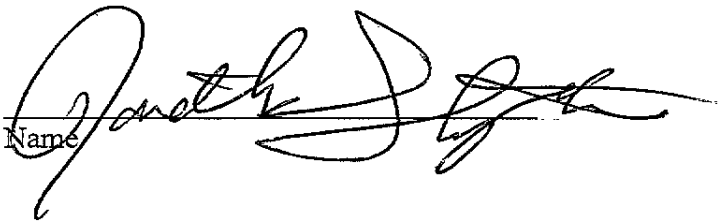
