This Corporation shall exist perpetually beginning five (5) days prior to the date of filing of these Articles of Incorporation.

**ARTICLE V**  
**REQUIRED CAPITAL**

This Corporation shall begin business with capital of not less than One Hundred Dollars (\$100.00).

**ARTICLE VI**  
**CAPITAL STOCK**

**REGISTERED AGENT AND OFFICE**

When not prohibited by law, any action of the shareholders of this Corporation may be taken without a meeting if consent, in writing, setting forth the action so taken, shall be signed by all the persons who would be entitled to vote upon such action at a meeting and filed with the secretary of the Corporation as part of the corporate records. **ARTICLE XII**  
**INSPECTION OF BOOKS AND RECORDS**

The Corporation shall from time to time determine whether and to what extent and at what time and place and under what condition and regulations the accounts and books of the Corporation (other than the stock book) or any of them shall be open to inspection of shareholders; and no shareholders shall have any right of inspecting any account, book or document of this Corporation except as conferred by statutes, unless authorized by a resolution of the shareholders or by the Board of Directors.

**ARTICLE XV**

Every Officer and every Director of this Corporation shall be indemnified by the Corporation, as permitted by law, against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him or her in connection with any proceeding to which he

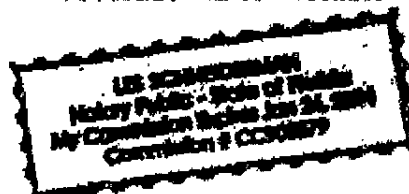
