The undersigned hereby associate themselves together for the purpose of becoming a body corporate under the laws of the State of Florida and do hereby certify, make, TS subscribe, acknowledge, and file in the Office of the Department of State, this Certificate:

- 1. The name of the corporation shall be: Superior Postal Express, Inc.
- 2. The general nature of the business to be transacted is as follows: Any and all lawful business.

To manufacture, purchase or other wise acquire, own, mortgage, pledge, sell, assign and transfer or otherwise dispose of, to invest, trade, deal in and with goods, wares, and merchandise and real and personal property of every class and description.

To buy, sell, purchase, assign, hypothecate and otherwise deal in notes, mortgages, bonds and other evidences of indebtedness secured and unsecured, guaranteed, insured or of conventional type.
