### ARTICLES OF INCORPORATION OF ALADAT, INC.

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I.

NAME: The name of this corporation is ALADat, INC. and the principal place of business shall be 3021 Airport Road,

Crestview, FL 32539.

#### ARTICLE II.

**DURATION:** The corporation shall exist perpetually.

#### ARTICLE III.

PURPOSE: The purpose or purposes for which this corporation is organized is to engage in the business of computer software development and sales, and/or any activity or business permitted under the laws of the United States and the State of Florida.
