### ARTICLE SIX-PURPOSE

## ARTICLE NINE- AMEMDMENT

These Articles of Incorporation may be amended as provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders meeting by a majority of the stock issued and entitled to be voted, unless all of the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Article of Incorporation be made.

The Board of Directors of this corporation shall consist of one or more directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the stockholders in accordance with the bylaws of the Corporation. The directors may be authorized and require the payment of the reasonable expenses incurred by directors in attending meetings of the directors.

Nothing in this Article shall be construed to preclude a director from serving the corporation in any other capacity and receiving compensation therefor.

Unless otherwise expressly prohibited by the Florida General Corporation Act, and except as otherwise provided in the foregoing sentence, the Board of Directors of the Corporation shall have the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to, any person made, threatened to be made, a party to any action, suit, or proceedings by reason of the fact that he is or was an officer, employee or agent of the corporation, partnership, joint venture, trust or other enterprise.
