ARTICLE I

Name

The name of the Corporation shall be Collier Star Corporation.

Registered Office and Registered Agent

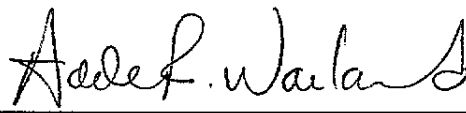
