THE UNDERSIGNED, acting as Incorporator of the BEACON COLLECTION SERVICES, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following, ARTICLES OF INCORPORATION for such corporation:

ARTICLE I

NAME

The name of the corporation shall be:

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

GENERAL PURPOSES

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.
