

ARTICLES OF INCORPORATION OF MAGDY FALESTINY, P.A.



The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is MAGDY FALESTINY, P.A. with a principal office and mailing address of 1500 U.S. Highway North 441, Suite 1834, The Villages, FL 32159.

ARTICLE II - COMMENCEMENT AND DURATION

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE III - PURPOSE

The general purposes for which this Professional Service Corporation is formed is for the practice of medicine.
