The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: **FIRST COMPANY, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation is: 622 Summit Street, Eustis, FL 32726.

ARTICLE III. PURPOSE
