The name of the corporation shall be: PELAEZ AUTO PARTS, INC.

ARTICLE II.

The principal place of business of the corporation shall be 8321 Via di Veneto, Boca Raton, Florida 33496.

ARTICLE III.

EFFECTIVE DATE

The general purpose for which this corporation is initially organized shall be the transaction of all business for which corporations may be incorporated under the laws of the State of Florida.
