**ARTICLES OF INCORPORATION
OF

ARTICLE I

Initial Board of Directors



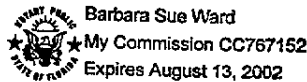
