I was recently made aware that my corporation had been administratively dissolved due to nonpayment of the Annual Fee for 2003. Although the dissolution notice was apparently mailed out on September 19, 2003, it was just recently given to me.

Not knowing exactly what this was about, I asked my accountant. He explained to me that I should have paid the annual renewal fee (of \$150.00) on or before May 1, 2003 to keep my corporation active in your system.
