The unsigned subscribers to these Articles of Incorporations and natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I – NAME

The name of the corporation is *First Active Realty, Inc.*

ARTICLE XI – REGISTERED RESIDENT AGENT

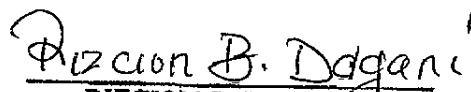
The registered resident agent for this corporation shall be indicated on the attached Certificate and the said agent may be replaced in accordance with the by-laws.
