**ARTICLES OF INCORPORATION**  
**OF**  
**QUAH ENTERPRISES, INC.**

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the Corporation shall be: QUAH ENTERPRISES, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office of the Corporation shall be located at 10217 Newington Place, Tampa, Fl. 33626 but the Corporation shall have power to establish branch offices and other places of business at such other places within or without the State of Florida, as may be determined and deemed expedient by the Directors.
