**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
LORD'S GYM SEMINOLE COUNTY, INC.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **LORD'S GYM SEMINOLE COUNTY, INC.**, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **LORD'S GYM SEMINOLE COUNTY, INC.**
2. The original Articles of Incorporation for the corporation were filed on April 12, 2002, and assigned Charter No. P02000040218.
3. By written consent executed on October 18, 2002 by the sole shareholder and directors of the corporation, the sole shareholder and directors have approved, authorized and directed that the Articles of Incorporation of the corporation shall be amended to change the name of the corporation to "LINE-X OF ORLANDO, INC.". The amendment was approved by the sole shareholder of the corporation and the number of votes cast for approval was sufficient.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE I - NAME**

The name of this corporation shall be **LINE-X OF ORLANDO, INC.**
