CERTIFICATE OF INCORPORATION

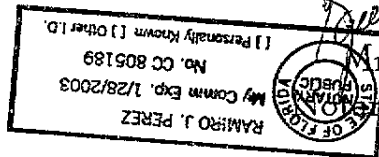


