

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation is **QUALITY LIFE-CARE SOLUTIONS, INC..**

**ARTICLE II**

The existence of this corporation shall commence upon the filing of these Articles and its existence shall be perpetual.

**ARTICLE III**

The general nature and purpose of Quality Life Care Solutions, Inc. is to provide quality home based support services to individuals with developmental and other physical disabilities and their families, and to engage in the transaction of any lawful business for which corporations may incorporate. This corporation shall be able to acquire, own, hold, manage and control real and personal property of every description, including stock in any corporation, and to sell and convey, mortgage, pledge, lease or otherwise dispose of such property or any part thereof, and to lend money either upon or without security.

**ARTICLE IV**

**ARTICLE V**
