ARTICLES OF INCORPORATION

OF

TOM BISHOP, P.A.

The undersigned hereby enters into these Articles of Incorporation for the purpose of establishing a corporation in accordance with the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be TOM BISHOP, P.A.

ARTICLE II

This corporation shall have perpetual existence.

The business of this corporation is limited to selling insurance only and related incidental servicing of insurance clients.
