ARTICLES OF INCORPORATION

OF

MYERS PRESSURE CLEANING, INC.

ARTICLE I - NAME:

The name of this corporation is: MYERS PRESSURE CLEANING INC., hereinafter referred to as the "Corporation".

ARTICLE_II_ - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
