**ARTICLE I - NAME**

The name of this corporation is CRAZY8.COM, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually.

**ARTICLE III - PURPOSE**

**ARTICLE IV - CAPITAL STOCK**

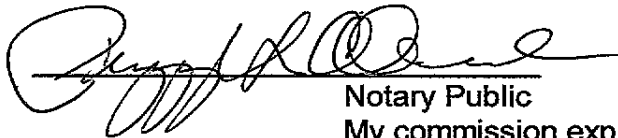
