ARTICLES OF INCORPORATION

ARTICLES I - NAME

The name of the Corporation is TRELAUNEY ENTERPRISES, INC.

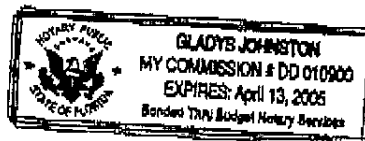
