ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is Frank Mora, Inc. at 408 Monroe Avenue, Cape Canaveral, Florida 32920 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".
