OF

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

SECRETARY OF STATE  
TALLAHASSEE FLORIDA

1. The name of the corporation is, CASAS & ZAMBRANO, M.D., P.A. (the "Corporation").
2. The principal office of the Corporation is 8740 N. Kendall Dr. #218, Miami, FL 33176, FL. 33154.
3. The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of Common Stock, par value \$0.01 per share.
4. The street address of the initial registered office of this Corporation is 407 Lincoln Road, Penthouse SE, Miami Beach, FL 33139, and the name of the initial registered agent of this Corporation at that address is The Law Offices of Craig M. Dorne, PA.
5. The name and address of the person signing these Articles of Incorporation as incorporator is Craig M. Dorne.
6. This Corporation will be a doctor's office and medical group practice.
7. The Corporation shall have two (2) directors initially. The name and address of the initial directors are:

The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one.

8. The existence of the corporation shall be perpetual. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five (5) days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

9. The initial bylaws of this corporation shall be adopted by the directors.

Bylaws shall be adopted, altered, amended or repealed from time to time by either the shareholders or the board of directors, but the board of directors shall not alter, amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the directors.

10. This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any such right conferred upon the shareholders is subject to this reservation.

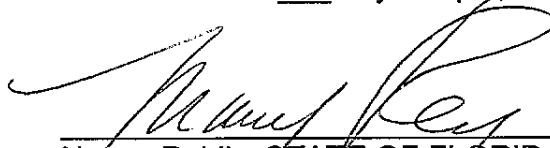

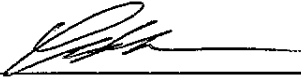

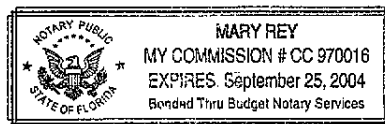
