ARTICLES OF INCORPORATION OF

Falcon Financial Management Advisory Services, Inc.

The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is: Falcon Financial Management Advisory Services, Inc.

ARTICLE II - Principal Office and Mailing Address
