# ARTICLES OF INCORPORATION OF

#### **ARTICLE 1 - NAME**

#### ARTICLE 6 - CORPORATE CAPITALIZATION

- . 6.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is 1,000 Shares of common stock, each share having the par value of 1.00.
