**Articles of Incorporation**

of

**ARTICLE I. CORPORATE NAME**

The name of this Corporation is JEM HealthCare Associates, Inc.

**ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS**

The Corporation principal office and mailing address is 4674 Devonshire Blvd, Palm Harbor, FL 34685.

**ARTICLE III. NATURE OF BUSINESS**

The general nature of the business to be transacted by this Corporation is to engage in any business as permitted under the laws of the State of Florida.

The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.

**ARTICLE V. TERMS OF EXISTENCE**

This Corporation shall have perpetual existence commencing upon these articles filed.

**ARTICLE VI. REGISTERED AGENT AND INITIAL REGISTERED OFFICE AND ACCEPTANCE BY THE REGISTERED AGENT**

The Registered Agent and the street address for the Initial Registered Office of this Corporation in the State of Florida shall be Judith A. Mattea 4674 Devonshire Blvd. Palm Harbor, FL 34685. Directors from time to time may move the Registered Office to any other address in the State of Florida. ### **ARTICLE X. AMENDMENT**

These Articles of Incorporation may be amended in the manner provided by law. This Corporation shall indemnify any officer or director or any former officer or director, to full extent permitted by law.
