#### ARTICLES OF INCORPORATION

OF

#### KARL LARSENS ENGINE REPAIR, INC.

#### ARTICLE ONE

The name of this corporation is KARL LARSENS ENGINE REPAIR, INC. and the mailing address of the corporation shall be 2564 SW 28th Avenue, Cape Coral, FL 33914.

# ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

#### ARTICLE THREE

The duration of the corporation is perpetual.

### ARTICLE FOUR

The general purposes for which the corporation is organized are:

- 1. To engage in the business of marine and lawn equipment engine repair.
- 2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.


