**ARTICLES OF INCORPORATION**

**ARTICLE ONE**

The name of this corporation is KARL LARSENS ENGINE REPAIR, INC. and the mailing address of the corporation shall be 2564 SW 28<sup>th</sup> Avenue, Cape Coral, FL 33914.

**ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

**ARTICLE THREE**

The duration of the corporation is perpetual.

**ARTICLE FOUR**

The general purposes for which the corporation is organized are:

1. To engage in the business of marine and lawn equipment engine repair.
2. To transact any other lawful business for which corporation may be incorporated under the Florida General Corporation Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

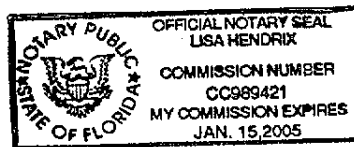
