The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby form a Corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation shall be: International Baseball Sports Management Inc.
The principal place of business of this Corporation shall be: 17106 Carrington Park Drive,
Apartment Number 603, Tampa, Florida 33647.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage in, or transact, any or all lawful activities or business permitted under the Laws of the United States, the State of Florida or any other State, Country, Territory or Nation.
