I, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation is VRUNDA INC.

#### ARTICLE II

The principal place of business and mailing address of this corporation shall be 4610 North Armenia Avenue #106, Tampa, Florida 33603. The Directors may from time to time designate such other address and place for the principal office of the corporation, as they deem appropriate.
