OF

ARTICLE I. NAME

The name of this corporation is
AJ Cosmetics Inc.

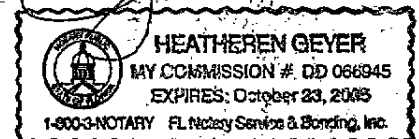
