CORPORATE EXISTENCE

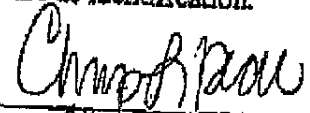

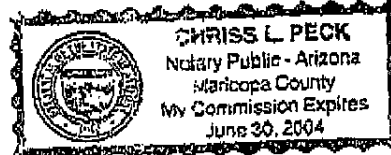

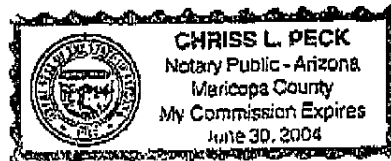
