**ARTICLES OF INCORPORATION
OF

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I.

Name

The name of the Corporation is **JP Surveillance Franchising Corp.**

II.

Term of Existence

The date when corporate existence will commence is April 15, 2002 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

III.

Principal Office

The principal office and mailing address of the Corporation is 4497 Golden Lake Drive, Sarasota, FL 34233.

IV.

Capital Stock

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.

V.

Initial Registered Office and Agent

Therefore, the terms and provisions of Section 607.0902 will not apply with respect to any control-share acquisition of any equity securities of the Corporation and the equity securities of the Corporation will have any and all other rights and privileges available under the Act.

Bylaws

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.

Indemnification

The Corporation will indemnify any director or officer or any former director or officer, to the fullest extent permitted by law.
